

2016 HILLCLIMB REGULATIONS AND ELIGIBILITY REQUIREMENTS

Section I License Regulations

- **A.** AMA Pro Racing licensed riders not competing in AMA Pro Racing sanctioned events for a period of three years may lose their prior classification.
- **B.** Applicants renewing a license that has been expired for three or more years must complete a Hillcimb Eligibility Questionnaire.
- **C.** All rider classifications are issued at the discretion of AMA Pro Racing.
- **D.** All new applicants <u>must</u> complete an Eligibility Questionnaire.

Section II License Classification/Eligibility

A. Pro Sport License

An AMA Pro Racing "Pro Sport License" is issued to eligible riders who have reached the age of 16 years and meet one or more of the following criteria:

- 1. Current licensed Pro Sport riders who have been licensed for less than two years*
- 2. 1 year of current hillclimb racing experience and at least one of the following:
 - i Finish in the top 20% of amateur classes at AMA Grand Championship or AMA District Hillclimb Points
 - ii Hold an Amateur "A" or "B" classification in his/her racing discipline
- 3. Or can prove top level amateur experience

Riders may advance to Expert Singles if they meet eligibility requirements for Expert Singles Class before two years of licensure.

*Riders who have held a Pro Sport license for two years will advance to Expert Singles Class.

Pro Sport licensure will be a maximum of two years before advancing to the Expert Singles Class

B. Expert Singles License

An AMA Pro Racing "Expert Singles license" is issued to eligible riders who meet either of the following criteria:

- 1. Current licensed Expert Licensed riders.
- 2. The top 3 riders in the final Pro Sport Class Standings from the previous 3 seasons are qualified to move up to an Expert Singles license; the remainder of the field must submit a qualification letter to AMA Pro Racing for approval.
- 3. Licensed Pro Sport Class riders who have held a Pro Sport Class license for one year and had three podium finishes within the previous 3 years.
- 4. Three years Amateur Hillclimb experience with at least one of the following
 - i Top 10% AMA Amateur Grand Championship finish and/or AMA Amateur Hillclimb District Points
 - ii "A" classified rider in another racing discipline
- 5. Rider holding a Professional License from another Series or Racing Discipline
- 6. Can prove top level amateur experience

Expert Singles Licensed Riders may or may not be granted to hold Expert Xtreme/Unlimited License, depending on eligibility.

C. Expert Xtreme/Unlimited License



An AMA Pro Racing "Expert Xtreme/Unlimited license" is issued to eligible riders who meet either of the following criteria:

- 1. Current licensed Expert Xtreme/Unlimited Licensed riders.
- 2. Licensed Pro Sport Class or Expert Singles Class riders who have held exhibited top level competition in the AMA Pro Hillclimb Series
- 3. Three years Amateur Hillclimb experience with at least one of following:
 - i Top 10% AMA Amateur Grand Championship finish and/or AMA Amateur Hillclimb District Points
 - ii "A" classified rider in another racing discipline
- 4. Rider holding a Professional License from another Series or Racing Discipline
- 5. Can prove top level amateur experience
