Branding Requirements:

- Bodywork with standard production colors must be used.
- Honda logo must be legible and prominently featured on the machine.
- Honda logo must be located on both sides of either the seat, radiator shrouds or front and rear fender.

How to Register:

Branding Requirements:

- The Husqvarna logo and plastic components must be displayed for contingency eligibility.

How to Register:

- The Contingency Enrollment Form must be completed and the Husqvarna FC450 on file prior to race date.
- All Husqvarna contingency payments will be paid via check or direct deposit within 30 days of results verification.
- Competitors must ride a Husqvarna for the entire series (18 events) to be eligible for series-end rewards

Branding Requirements:

- Kawasaki Lime Green must be the dominant color
- Kawasaki logos must (black or white only) be on both sides of the motorcycle.
- Kawasaki must be on the chest portion of leathers. Patches can be purchased or requested from Team Green.

How to Register:

- Contact Team Green Contingency to verify engine number and submit a photo of the race bike at teamgreen.contingency@kmc-usa.com.
- Following registration, riders will receive the Kawasaki Contingency Rewards MasterCard® (debit card) and automatic payments will be deposited directly to your card after Kawasaki receives "official" race results.
- No payments will be issued after January 15, 2019. Please report any missed payments or errors within 30 days.
- **Competitors MUST enroll and verify registered VIN for qualifying vehicles.**

Branding Requirements:

- The Yamaha logo **must** be displayed on the left and right side of all motorcycles.
- The original color plastic components **must** remain on all machines to be eligible.

How to Register:

- Contingency will be paid to the Warranty Registered owner. If warranty registered owner will not be competing, but sponsoring a rider, contingency will be paid to the rider.
- Following registration bLU cRU members will receive a Yamaha "bLU cRU" debit card and contingency payments will be issued to the reloadable debit card after confirmation of results.
